The type of personal information we collect.

We currently collect and process the following information:

Personal identifiers, contacts and characteristics including name, address, phone number, email and date of birth.

Some medical information

Next of kin details

Photo consent

How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

Access to participate in activities and workshops.

We use the information that you have given us in order to

- Contact you about activities and events.
- Collate anonymised statistics for evaluation and funding purposes.
- Celebrate and publicise our work.

We may share this information with emergency services, local organisations. the public and journalists..

Under the UK General Data Protection Regulation (UK GDPR), the lawful bases we rely on for processing this information are:

- Your consent. You are able to remove your consent at any time. You can
 do this by contacting info@blossomingcommunities.org.co
- We have a legal obligation.

How we store your personal information

Your information is securely stored in a locked filing cabinet, on a secure laptop or on an encrypted cloud storage.

- We keep your personal identifiers, contacts and characteristics including name, address, phone number, email and date of birth, medical and next of kin information for up to 18 months after the last time you participate in an activity with Blossoming Communities. This information will then be shredded if it is in paper form or securely deleted from computer hardware by a IT professional.
- Photo consent, photographs and audio-visual recordings will be kept and used for celebration and promotional activities.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
